On the 9th a member of the public phoned Police stating that they had just disturbed persons attempting to break into sheds in Westcott and they had made off in a vehicle towards Dorking. The Police radio operator gave the information to a Police patrol and our operator used the Westcott Road junction with Vincent Lane camera to check for vehicles coming from Westcott. As the Police gave out the registration number our operator saw the vehicle arrive in Dorking. They immediately updated the Police with its location but almost immediately the vehicle drove out of our view. As a Police patrol neared the area our operator saw the vehicle again as it emerged from the area that it had been in and drove off along Station Road. We immediately notified the Police and they were able to stop the vehicle, although not quite in our view. Three males arrested for burglary, a good result!

On the 12th in Redhill a caller to the Police advised that a female who had assaulted the informant the previous week had just entered the Abbott Pub. This assault had been reported at the time but the suspect was unknown. We were immediately able to cover both exits from the Abbott Pub whilst we waited for a Police patrol to attend. When Police officers arrived at the Pub they asked for an update and we were able to inform them that the suspect was outside the Pub smoking a cigarette allowing the officers to speak to her without having to enter the Pub. As the officers spoke to the suspect she became violent and we had to request urgent assistance from further Police officers. One in custody for the original assault and further arrested for assaulting the Police officers attempting to arrest and restrain her.

On the 22nd a report was received by the Police from a female in Redhill to state that she had been approached by two males and asked for money in a very overbearing way. She was concerned and gave the Police descriptions. A local neighbourhood Police officer was in Redhill at this time and he was approached by another member of the public stating that he had been approached by two males who had forced him to go to the cash point and withdraw money and hand it over to them. We were immediately able to review our recorded footage and found the offence being committed. Our operator was also able to name the two suspected offenders who are very well known in the local area. With the information we provided to the Police they were able to locate and arrest one suspect almost immediately although the other suspect remained outstanding until arrested later that night.
